1. Competition Overview

De Jagers Vredendal is running a community prize draw open to customers of the Vredendal branch, running in two separate rounds:

Round	Entry Period	Draw Date
Round 1	12 June 2026 – 30 June 2026	30 June 2026
Round 2	1 July 2026 – 31 July 2026	31 July 2026

Entries from Round 1 are **not carried over** to Round 2. Each round is treated as a separate competition.

2. How to Enter

- 2.1 Any customer who makes a purchase at the De Jagers Vredendal branch during the applicable competition period qualifies for one (1) entry per transaction.
- 2.2 To enter, the customer must write the following on their till slip: • Full name • Contact telephone number • The name of the institution they wish to nominate
- 2.3 The completed slip must be placed in the designated entry box at the Vredendal branch before close of business on the last day of the applicable round.
- 2.4 No purchase beyond the ordinary transaction price is required to enter. No separate entry fee will be charged.
- 2.5 Illegible, incomplete, or damaged slips will be disqualified.
- 2.6 Multiple transactions on the same day each qualify for a separate entry. Only one entry per transaction will be accepted.

3. Eligibility

- 3.1 The competition is open to all customers of De Jagers Vredendal who are 18 years of age or older.
- 3.2 Employees, directors, agents, and immediate family members of De Jagers or any associated entity are not eligible to enter or win.

4. Eligible Institutions

- 4.1 Participants may nominate any sport club, school, or charitable organisation physically located within the **Matzikama Local Municipality**, which includes the following towns and settlements:

Vredendal, Lutzville, Koekenaap, Klawer, Vanrhynsdorp, Ebenhaezer, Papendorp, Doringbaai, Strandfontein, Bitterfontein, Nuwerus, Kliprand, Stofkraal, Molsvlei, Putsekloof and Rietpoort.

- 4.2 Institutions located outside the Matzikama Local Municipality area do **not qualify**, regardless of being drawn.
- 4.3 If a drawn slip nominates a non-qualifying institution, **both prizes are forfeited** and a redraw will be conducted. It is the participant's responsibility to ensure their nominated institution qualifies before submitting their entry. This will be clearly communicated at the point of entry.
- 4.4 De Jagers reserves the right to verify the eligibility and location of any nominated institution prior to awarding prizes.
- 4.5 An institution may be nominated by multiple participants. Winning a round does not disqualify an institution from future rounds.

5. Prizes

Individual Prize	Customer named on the drawn slip	R1 000 De Jagers Pasella Voucher

- 5.1 Both prizes are awarded on the basis of a single drawn slip — the customer wins the individual prize and their nominated institution wins the institution prize.
- 5.2 Prizes are not transferable and may not be exchanged for cash or substituted for other goods or services.
- 5.3 The R1 000 De Jagers Pasella Voucher is redeemable at De Jagers stores only and **expires one (1) year from the draw date** of the relevant round.
- 5.4 De Jagers reserves the right to substitute a prize of equal or greater value if circumstances require.

6. Draw Process

- 6.1 The draw will take place at the De Jagers Vredendal branch on the draw date specified per round.
- 6.2 The draw will be overseen and certified by an independent expert (accountant, attorney, or registered auditor) as required by the Consumer Protection Act Regulations. Where physical presence is not practicable, the draw will be recorded in full on video and submitted to the independent expert for review and written certification. The certified report will be retained for a minimum of 3 years.
- 6.3 One slip will be drawn at random from the entry box. That single slip determines both the individual winner and the nominated institution winner for that round.
- 6.4 Participants are **not required** to be present at the draw. The draw will proceed regardless of attendance.
- 6.5 The result of each draw is final and binding.

7. Winner Notification

- 7.1** The individual winner will be contacted using the telephone number on their slip within **5 business days** of the draw.
- 7.2** De Jagers will make reasonable efforts to contact the winning institution within **5 business days** of the draw.
- 7.3** If the individual winner cannot be contacted or does not claim their voucher within **30 days** of the draw date, De Jagers reserves the right to conduct a redraw.
- 7.4** If the winning institution cannot be contacted or formally declines the prize within **30 days** of the draw date, De Jagers reserves the right to donate the R10 000 to an eligible Matzikama institution of their choosing, or to conduct a redraw.
- 7.5** De Jagers may announce winners on their social media platforms and in-store. By entering, participants consent to their first name and nominated institution being published. Participants who do not wish to be named may notify De Jagers in writing prior to the draw.

8. Data Protection

- 8.1** Personal information collected on entry slips (name and telephone number) will be used solely for administering this competition.
- 8.2** Information will not be shared with third parties or used for marketing purposes without the participant's consent.
- 8.3** All entry slips will be securely destroyed after the mandatory 3-year record-keeping period.

9. General

- 9.1** De Jagers reserves the right to amend, suspend, or cancel the competition at any time, with reasonable notice where possible.
- 9.2** These rules are subject to the Consumer Protection Act 68 of 2008 and its Regulations.
- 9.3** A copy of these rules is available free of charge on request at the Vredendal branch or at www.dejagersonline.co.za.
- 9.4** By entering the competition, participants agree to be bound by these Terms and Conditions.
- 9.5** De Jagers' decision on all competition matters is final.
